

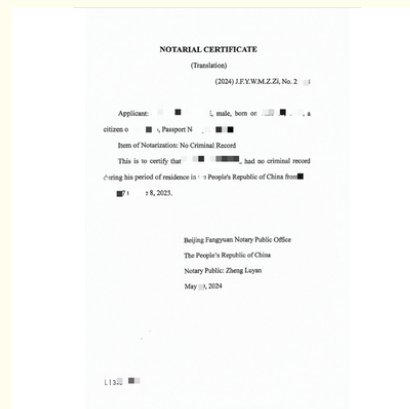

Step 1: Applying for the No Criminal Record Certificate

Foreigners can apply for the No Criminal Record Certificate at the Exit-Entry Administration Detachments of the Public Security Sub-bureaus in various districts of Beijing. For contact details of the district sub-bureaus, please visit the National Immigration Administration website and select "Beijing".

Eligibility

Hold a residence permit issued by Beijing.
Have resided in Beijing for 180 days or more.

Required Documents

Passport
Temporary Accommodation Registration Form for Overseas Personnel (not mandatory)
Power of Attorney (if a third party is authorized to apply on behalf of the applicant)

Processing Time

1-3 working days.

After obtaining the No Criminal Record Certificate from the Public Security Bureau, it needs to be submitted to a local notary office for notarization and translation. We recommend the Beijing Fangyuan Notary Office, known for its extensive experience in notarizing certificates for foreigners.
