No Criminal Record Certification - SHENZHEN

This guide outlines the process for foreign nationals to obtain a Certificate of No Criminal Record during their residence in Shenzhen, China. This certificate, known as a police clearance in other countries, follows the regulations set forth by the Shenzhen Municipal Public Security Bureau and is essential for various purposes such as immigration and employment.

Shenzhen has been at the forefront in standardizing the requirements for foreign nationals' applications for No Criminal Record Certificates. The Shenzhen Municipal Public Security Bureau established the No Criminal Record Certificate Office on March 13, 2014, which later became part of the Shenzhen Municipal Administrative Service Center in 2018. As of July 10, 2023, the application acceptance venue has been relocated to the Exit-Entry Administration of Shenzhen Municipal Public Security Bureau, while the approval process remains under the No Criminal Record Certificate Office.

# Step 1: Applying for the No Criminal Record Certificate

#### Where to Apply?

Foreign nationals can apply for the No Criminal Record Certificate at the Exit-Entry Administration of Shenzhen Municipal Public Security Bureau. Here are the contact details:

#### Eligibility

Hold a residence permit issued by Shenzhen and have proof of temporary residence registration in Shenzhen. Have resided in Shenzhen for 180 days or more.

#### **Required Documents**

Passport (Original preferred; if only a copy is available, it must be notarized by the foreign affairs department of the applicant's country or authenticated by the Chinese embassy or consulate in that country.)

Temporary Residence Registration Form

Power of Attorney, if applying through a third party (If the applicant is abroad, the Power of Attorney must be notarized by the foreign affairs department of their country or authenticated by the Chinese embassy or consulate in that country.)

#### **Processing Time**

Usually 3 working days.

#### **Sample Certificate**

The "Regulations on Handling Criminal Record Inquiries by Public Security Organs" provides a basic template for the Certificate of No Criminal Record. This template includes a QR code and a statement of no criminal record. The QR code is used to verify the authenticity of the certificate. # **Step 2: Notarizing the No Criminal Record Certificate**

#### Where to Apply?

After obtaining the No Criminal Record Certificate from the Shenzhen Municipal Public Security Bureau, submit it to a local notary office for notarization. For immigration purposes to countries like the United States, Canada, and Australia, the Chinese No Criminal Record Certificate must be notarized by a local notary office and accompanied by an English translation.

In Shenzhen, there are numerous notary offices available for handling notarizations of No Criminal Record Certificates. The Shenzhen Notary Public Office, located at the 17th floor of Xingye Bank Building, 4013 Shennan Road, Futian District, is known for its extensive experience in handling such cases.

#### **Required Documents**

Passport

No Criminal Record Certificate issued by Shenzhen Public Security Power of Attorney, if applying through a third party
