For foreign nationals who have lived in Shenzhen and require a Certificate of No Criminal Record (also known as a police certificate, police check, or police clearance) for purposes such as immigration, employment, or other official procedures, we provide comprehensive services to assist you throughout the entire process.

Shenzhen was one of the first cities in China to implement standardized requirements across the city for the issuance of Certificates of No Criminal Record to foreign nationals. On March 13, 2014, the Shenzhen Public Security Bureau (PSB) established the Office of No Criminal Record Certificate, a specialized department dedicated to this matter. Although the application filing location has changed over the years, with the most recent change on July 10, 2023, moving it to the Exit and Entry Administration of Shenzhen Municipal Public Security Bureau, the Office of No Criminal Record Certificate remains the issuing authority.

STEP 1: Application for Certificate of No Criminal Record

Your application for a Certificate of No Criminal Record must be submitted to the Exit and Entry Administration of Shenzhen Municipal Public Security Bureau. We assist you with preparing and filing your application to ensure a smooth process. Below is the contact information:

Eligibility

To be eligible for a Certificate of No Criminal Record in Shenzhen, you must meet the following criteria:

Have had residence permits issued from Shenzhen.

Have lived in Shenzhen for 180 days or longer.

Processing Time

The processing time for the certificate is typically 3 working days.

Required Documents

The following documents are required for your application:

Original passports (copies must be either apostilled by the issuing country's foreign affairs department or authenticated by a Chinese consulate/embassy if the originals are unavailable).

Temporary Residence Registration Forms.

Power of attorney, if applicable (must be apostilled or authenticated as above if the applicant is abroad).

STEP 2: Notarization of Certificate of No Criminal Record

Once the Certificate of No Criminal Record is issued, it must be notarized for use in immigration or other official purposes. We guide you through the notarization process, which involves submitting the certificate to a local notary office for issuance of a Notarial Certificate of No Criminal Record with an English translation.
