Guide to Obtaining a Certificate of No Criminal Record in Chongqing

This guide is intended to assist foreign nationals in obtaining a Certificate of No Criminal Record in Chongqing, China. In other countries, this document is also known as a police certificate, police check, or police clearance.

Foreign nationals may need this certificate for various reasons, including immigration, employment, and more. Typically, the Certificate of No Criminal Record is not acceptable for these purposes until it has been notarized by a local notary office in China. Additionally, for use in certain countries, the certificate must be apostilled by China's Ministry of Foreign Affairs or authenticated by the embassy of the country where it is to be used. This guide covers the two primary steps: "STEP 1: Application for Certificate of No Criminal Record" and "STEP 2: Notarization of Certificate of No Criminal Record".

STEP 1: Application for Certificate of No Criminal Record Where to Apply?

A foreign national who has lived in Chongqing may apply to the local exit and entry administration of Chongqing PSB that has jurisdiction over the applicant's residence in Chongqing. If you have lived in multiple districts, go to the exit and entry administration in the district of your last residence. China's National Immigration Administration (NIC) publishes the contact information of exit and entry administration offices in every city of China. Click the link to visit NIC's official website and select "Chongqing" to find the office in your district.

Who Are Eligible?

Have had residence permits issued from Chongqing.

Have lived in Chongqing for 6 months or longer.

Processing Time

Typically, the application is processed on the spot.

Required Documents

Passports

Power of attorney, if a third-party is appointed to handle the application.

Application Statement regarding your personal information, the purpose of the application, and the period of residence in Chongqing sought to be covered by the certificate.

Sample Certificate of No Criminal Record

The Provisions on the Handling of Criminal Record Check by Public Security Organs provides a basic model Certificate of No Criminal Record. The model contains a QR code for verification and a statement regarding no criminal record. Local police in different cities issue the certificates with slight variations in the layout. STEP 2: Notarization of Certificate of No Criminal Record Purpose:

Most foreign nationals need a Certificate of No Criminal Record for purposes of immigration and employment in other countries. A Certificate of No Criminal Record issued by local Chinese police is typically not acceptable for these purposes. To be used outside of China, the certificate needs to be notarized by a local Chinese notary office. (In some cases, it also needs to be authenticated/legalized by the embassy or consulate of the receiving country in China. For more information about that process, please check our authentication guide.)

Where to Apply?

There are multiple notary offices in Chongqing that are licensed to issue Notarial Certificates of No Criminal Record. Chongqing Notary Public Office is the major notary office in Chongqing.

Processing Time

The notarization process typically takes 3 to 5 working days.
